Mr. Riddick moved to approve the following minutes:

### E. AWARDS AND RECOGNITIONS

Dr. Prior congratulated Emily Srebro, a junior at Montclair High School for her extraordinary talents in gymnastics. Emily Srebro represented Montclair High School very well at the 2006 Special Olympics In Shanghai, China walking away with five medals which included the Gold medal for floor exercises, 3 Silver medals, 1 for all around performance, 1 for uneven bars and 1 for vaulting and she won the Bronze medal for the balance beam. Emily's success can be attributed to her talent, hard work, strong will and a determined positive outlook.

### F. SUPERINTENDENT'S REPORT

Dr. Alvarez referenced some of the comments that he had made at the State of the Schools Address on Thursday evening. He stated that he introduced five big picture ideas, which consisted of things that need our focus and attention.

The first is the issue of the recent Supreme Court ruling regarding the assignment of students to magnet schools by race. While Montclair has a court-ordered mandate to integrate its schools, which is different than the Louisville and Seattle case where they were voluntary plans, certainly people will be watching what we are doing in Montclair and a challenge is likely. He stated that the decision of the Supreme Court ultimately may have some impact on what occurs in our school district. Nevertheless, we are working with lots of legal experts such as staff from the Department of Education, our attorneys, some professors at Columbia University, and members of the N.A.A.C.P. Legal Defense Fund. We are trying to think about what the implications might be for Montclair. He added that in the last couple of years we have not used race as a single indicator for student placement. Parent choice drives the system; 90% of families get their 1<sup>st</sup> or 2<sup>nd</sup> choice placement. Student assignments begin to sort itself out before we even use any other variable as an assignment measure. He stated that the message which we want to convey to the community is that what we do has merit, that the importance of diversity is something that continues to be a focus and is valued greatly. In review of this new ruling, race-conscious measures are in place and will be used for school assignments. We think that we are well positioned and that our magnet schools are doing the job that they were intended to do when they were first formed 30 years ago. He noted that, interestingly enough, we are celebrating our 30th Anniversary as a magnet school district.

The second big picture idea introduced was the China initiative, which was partly inspired by his trip to China this summer. This initiative would aid in giving thought to how students are prepared for the global economy and understanding that China represents 25% of the world's population and that China is preparing their students quite effectively to deal in the global economy. All of their children begin to learn English in the 3<sup>rd</sup> grade and by the time they are in 8<sup>th</sup> grade, they are as proficient as an English-native speaker. He stated that something will be done in order to pay attention to this larger vision of the world. There is a steering committee in place that is looking at initiating a Kindergarten or Grade 1 language program and another at the high school level.

Thirdly, he spoke about the notion of technology and classrooms of the future. This is inspired by some of the work that is being done at Montclair State University's highly technological environment that links students with other students from across the globe and provides access to the latest research from other universities. Connecting students with the outside world and preparing them with the knowledge of what

our students will need to know is essential as they prepare to go out into a very different world. He stated that the MFEE is excited about doing some fund raising for these classrooms of the future. He also noted

that a pilot program has been initiated to work with elementary staff in taking traditional lessons and converting them into technologically advance lessons.

He added that there are two other things related to technology: The first is increasing the utilization of Blackboard for all parents, where they could access what students are doing within their own classrooms. A lot of our schools are already doing this, but the goal is to get as many people on board as possible.

The second is offering on-line courses at the high school.

The fourth idea discussed was a Parent Education Advocacy, Communication and Engagement initiative, to get parents more fully involved in meaningful ways, as well as assisting parents who often have a negative outlook develop advocacy skills so that they interact more positively and become more connected with the schools.

He concluded that the fifth big picture idea was to look at school funding and create some advocacy and a real voice for districts like Montclair in Trenton. He added that Marybeth Rosenthal from the PTA and others have begun to converse with representatives in Trenton last year. He noted that although the district lost the \$1million grant, we received some additional funding from Trenton in the form of TARA, the Targeted At Risk Aid, but only for \$288,000. Even though the Governor is pushing for a new funding formula, and there is some talk that this might actually be a tiered formula that is going to get phased in over a couple of years; they are going to have to move pretty fast to give us any kind of input within the next couple of weeks, since the Governor usually delivers his budget message towards the end of January. We are still under the timeline of having to submit a budget to Trenton by March which has not changed.

# Audit Report, Fiscal Year 2006-2007

John Lauria from Samuel Klein & Co. stated that there are two separate reports every year. The smaller report is administrative compliance and performance for June. The recommendation of the smaller report is broken down into different categories as required by the State of New Jersey. (See attached synopsis of the audit report) In fact, the entire audit report is mandated by the State Department of Education.

He noted that the bigger report shows the financial status and the one schedule that needs attention is the budgetary comparison schedule. It tells us what the surplus number or the fund balance number is as of June of 2007. This has been broken down into a total surplus of \$6,089,813. The \$2,729,670 represents the undesignated surplus, which is 2% of the 2006-2007 general fund expenditures. \$282,858.00 of the \$6 million is designated for encumbrances, \$61,677.00 represents the adult school surplus, \$2,047,047.00 was appropriated in the 2007-2008 budget and \$968,560.00 will be appropriated in the 2008-2009 budget.

#### G. BOARD OF EDUCATION REPORTS

Mr. Barr stated the Academic Sub-committee will be meeting on Wednesdays.

Mrs. Taylor stated that she attended the NAACP dinner where the speaker addressed the topic of improvement to the school system.

Mr. Kautz stated that there seems to be some news from Trenton that they are going to try to put together a new school funding formula some time in early January. President Bush vetoed Congress'

fiscal 2008 funding bill out of the Department of Labor Health and Human Services and Education because it's

proposed spending level exceeded his budget request. The NSBA stated that the veto jeopardizes funding for Title I grants for disadvantaged students, special education, school improvement grants, teacher quality grants, career and technical education and other key programs that were slighted to receive needed increases. He added that there is supposedly an attempt to override the veto. The bill relates to education in that the proposed increases for education represents less than a 1% increase of the 2007 budget. This is an opportunity to reach out to your respective Congressman or Senator if you are in favor of the override. He concluded that with regards to the MFEE, he is thrilled to report that the fall 2007 grant requests totaled 128. This is a new record and they are requesting over \$128,000.00 in grant funding and very pleased to report that the budget is at or perhaps even above\$100,000.00 that is available. They have been very effective in getting the word out that money is available. Principals and teachers have been very effective at getting comprehensive grant requests to the MFEE.

Mr. Carlton stated that on December 6 there will be a Project Graduation fund raiser and asked for support. He noted that one of the issues that are dealt with in Montclair is the alternative minimum tax which takes back what we deduct on the property tax. There were Legislators working in Washington to get that done but the vote was not favored. The good news is that the Governor is looking in the coming year to add in \$60,000,000.00 to the state budget for the insurance program for low and moderate income children.

#### H. COMMENTS

#### 1. MHS Student Coalition

Danielle Martinez, president of the Student Coalition presented the following updates regarding activities taking place in the Montclair High School:

- •The Mock Trial Team season has begun.
- •The model competition at Rutgers, New Brunswick was a success and four prizes were won in all different categories.
- •The CSJ's Macaroni and Cheese drive to benefit the human needs food pantry was successful
- •The CGI's annual supply drive of canned and plastic goods was also successful.

She added that there is a new club called Rwanda Teens for Life that consists of a group of girls working along with the non-profit organization Rwanda Gift of Life to support survivors of the Rwanda genocide. As a reminder, she stated that the SVPA showcase musical review entitled "Welcome to Life" is coming up December 7, 8, and 14-16. She concluded that the Montclair

High School's Varsity football team has upcoming games with Hackensack, Bloomfield, and East Orange High Schools. The Student Coalition is preparing for the winter pep rally to bring back Mounties Spirit in Montclair High School. Preparations are underway for activities for Black History Month.

### 2. PTA

Mary Beth Rosenthal, PTA Council, has started a new fund raising mechanism which is a pilot project that is being undertaken where office and cleaning supplies can be purchased at Staples prices and the profit of every sale are donated to the non-profit organization. She encouraged all to participate in placing an order and that the Pilot program will be active during the Holidays. She added that there are 2,000 items on the web-site but eventually there will be about 7,000 items in the future. She concluded that the Renaissance PTA has a concern about the practice space for the basketball team at Renaissance school.

### 3. MEA

Dennis Murray stated that he had the opportunity to see Dr. Alvarez in action at the State of the Schools presentation, and was struck by several parts of his speech. He mentioned that Montclair should be very proud of the accomplishments in the areas that he referenced such as the celebration of 30-years of integrated education in Montclair just this past September, the promotion of a safe and encouraging learning environment, and educating the whole child. It is hoped that the June Supreme Court Decision will have little if any effect on what we in Montclair have worked so hard to maintain in giving all children the best education possible which is enhanced by the diversity of our schools. He concluded that Montclair has a great deal of reason to be thankful that include students who are ready to learn, instructional staff who engage students in that learning, building principals who assure that learning takes place, senior staff who aid in the creation of a safe and effective learning environment, a superintendent who believes in educating the whole child and a Board of Education who gives all the aforementioned the tools to sustain learning in our district.

- f. Mr. Carlton stated that he was impressed and very glad of the decision to hire Epic as construction managers and that it appears that they are really doing a good job for the district.

He mentioned that Scott White at the High School sends out email blasts to parents of students going to attend college encouraging them to get involved in the college experience. This is a good way to be educated on just how the college experience works and that information is provided to help set the mind frame.

He wished all a healthy Thanksgiving and said that there are lots of reasons to be grateful in Montclair. He concluded that he thinks that one of the things that makes Montclair unique

is that there is diversity, racially and in many other ways, ethnically and that one of the strengths when we come together from PTA's to Boards of Education is the ability to think of the needs of the people. There are people who may have medical and family challenges and to that extent we come together and try to address those concerns beyond the people who look just like us or act just like

us. It really becomes the strength of the town and when speaking about educating the whole child it is really educating the whole community.

## 2. Members of the Public

Agnes Rossi of 126 Lorraine Avenue, stated that she has four children in the system three attending Glenfield and one at Bradford and her question was is there a system in place to monitor whether the teachers are actually implementing at the classroom level the things that are stated in the curriculum and things that are brought up at meetings.

Dr. Alvarez responded that the answer to that question is yes. He stated that a couple of ways that is happening is that teachers submit lesson plans periodically which are checked by the principal to ensure they are consistent with the curriculum and that teachers also as differentiate for special education students and for SAIL students. The other is that principals do walk-through's, something that is done on a regular basis in order to know that what is going on in the classroom is really on target. He stated that he thinks that principals and house leaders do this at Glenfield through discussions and common planning periods.

Mrs. Rossi stated that as an example the Language Arts Curriculum specifically advises against traditional spelling tests that are teacher-generated lists for good reason because they don't improve student spelling. There is a ton of research to show this. However, she stated that her children have had traditional spelling tests every year in school. Therefore, she was very surprised to see it so clearly advised against in the Language Arts curriculum. She stated that it appears that teachers are given an enormous amount of autonomy and that is great if there is a great teacher, but if it is not such a good teacher then using outmoded practices is not so great.

Dr. Alvarez responded that he thinks that some occurrences of things that are happening in classrooms are not necessarily directly in-line with the curriculum. Part of that is because teachers do have a certain amount of autonomy once they are in their classroom; and perhaps some teachers are relying on methods that they have used for many years even though the curriculum advises them otherwise. What would be helpful to us when situations like this exist and parents have spoken to the teacher and do not see any change, then the next level of discussion should be with the principal. If no change is noted at that point, it should be discussed with our Assistant Superintendent for Instruction. We want to know about these things, so that we can refocus our teachers and get them back on track.

Mrs. Rossi stated that she feels that no questions regarding the opinions of parents or children's experience in the school system are asked and why there isn't any instrument for parents and children to give feedback on teachers, schools and principals.

Dr. Alvarez responded that there are a lot of opportunities that are provided for parents to give feedback. There are the Public Board meetings twice per month where people come to ask their questions and state their concerns. There is a parent survey that goes out every other year or every three years that provides us with feedback. School Review is a vehicle, along with monthly parent coffees at different schools, which are also an opportunity for parents to ask some of the uncomfortable questions.

John Lytle of 40 Union Street, stated that he enjoyed Dr. Alvarez' presentation at the State of the Schools Address. He also agreed with Mrs. Rossi in that he supports all of the opportunities of communication to which he is a participant in all of them. However, he feels that it is not enough because most of them are directed from the Board down to the parent but there is not enough listening the reversed way. He added

that every school review meeting that he has attended has had very little or no informal questions or answers but that it is usually a presentation of material.
