## I. SUPERINTENDENT'S REPORT

MHS Student Coalition – A report was presented by students David Ellmann, Jamie Fanous and Isabelle Foley. David Ellmann stated:

- both the girls and boys swim teams had won their first meets
- the Middle School Model Congress Club is very active
- Star Portal allows parents and students to view their grades
- high school seniors who applied at colleges early are now getting their responses

- important hockey game with Montclair Kimberley Academy on December 22 and urged everyone to attend
- 7. 2009 Audit Report

**Dana Sullivan** stated that the Corrective Action Plan which will be presented tonight will be forwarded to the County Superintendent of Schools after the Board's approval.

*John Lauria* of McEnerney, Brady & Company presented the 2009 Audit Report to the Board of Education. Mr. Lauria reported

- that 90% of the recommendations mainly pertain to school activity accounts and feels that changes in personnel contributes to these recommendations.
- there are eight recommendations that pertain to the elementary schools
- there is one recommendation pertaining to high school athletics
- there is one recommendation pertaining to the Adult School
- there are no issues of non-compliance with funds handled through the Board Secretary's Office
- the ASSA Application is not used for State Aid but it is a State requirement that it has to be put included in the Audit Report
- the large audit report document contains the schools financial condition at the end of the 2009 school year
- what the surplus dollars and reserved amounts will be used for
- what the fund balance was
- that the State has withheld two State Aid payment and hopes that they will release the payments

**John Carlton** questioned the money that is being withheld to municipalities.

**John Lauria** responded that the SDA had stopped funding but has heard that monies are now being released so he is not positive what the State is doing about releasing monies.

**John Carlton** asked if there were some other models for bookkeeping available to the schools so that some recommendations might be eliminated.

*John Lauria* responded that some other schools have a general student activity fund that would be funneled through the Board Office but this, of course, would be additional work for the Board Office and may require additional personnel.

**Dana Sullivan** noted that the schools have made great improvements over the past years and agreed that some of the problems are due to change in secretarial personnel. Mrs. Sullivan added that the Board is looking to purchase a school accounting package from Edu-Met and feels this will eliminate some problems. Mrs. Sullivan also noted that we do provide training for the new personnel.

*John Lauria* added that years ago the high school had problems and now this is not the case. Mr. Lauria also added that the State strictly mandates how the auditing firms have to report the slightest difference.

Montclair High School "Gateway to College National Network"

**Dr. Alvarez** stated that a presentation regarding the Gateway to College National Network would be made by James Earle and Ed Lebida. Dr. Alvarez noted that this program is housed at Essex County College and is a program for students who are struggling academically and not ready to go on to secondary education.

Ed Lebida thanked the Board for the opportunity to present this program. Mr. Lebida stated that Dr. Phil Linfante, Dean of Educational Services, and Lee Bella DeCastro, Assistant Dean of Academic Foundation, both from Essex County College were present to answer any questions and that they were both very instrumental in helping the high school develop this program.

Ed Lebida stated that Montclair High School is always seeking ways to service the entire population of the school to provide opportunities for students in non-traditional ways – alternate programs. Mr. Lebida noted some of the alternate programs that have been held at Montclair High in the past, such as the School of Performing Arts, the cross country and track courses overseen by Ray Spivey and the ABC Program Academy of Business and Careers.

Mr. Lebida explained that the Gateway to College was a new program giving students an opportunity to take college courses while attending high school and receiving credits for those courses. Mr. Lebida noted that many colleges across the country now house such a program and that it has been demonstrated that 88% of students involved in these programs are very successful. Mr. Lebida noted that the program gives students the opportunity to attend courses with college students.

Mr. Lebida noted that the students targeted this year will be current seniors that may not be eligible for graduation due to a deficiency of credits.

Mr. Lebida stated that the cost of the program is \$2500 per student per semester compared to the approximate cost of \$11,000 to educate a student. He noted that the tuition will be paid by Montclair Board of Education but books are provided by the college.

**Shelly Lombard** questioned how students would do better in an unstructured environment rather than a structured one. Mrs. Lombard also asked how a student applies for this program.

*Mr. Lebida* responded that in an unstructured environment, students have the opportunity to organize their time differently and allows them more flexibility in their schedules – personal and family and it is proven that they do better. Mr. Lebida also responded that there are monies set aside for alternate programs and this year students who are deficient in credits will be given the opportunity to enroll in the

program. He stated that in upcoming years, juniors and seniors who demonstrate competency that they will be able to perform at a college level will be targeted.

**Robert Kautz** questioned when the students receive a high school degree or their associate's degree and how long this takes.

*Mr. Lebida* responded that it would depend on when they enrolled in the course and when they attained their credits.

*Carmen Taylor* questioned who would provide transportation and that she felt it would take a very structured student to do well in this program.

*Mr. Lebida* responded that parents were going to be asked to provide transportation for their child since the Montclair Board of Education would be paying their tuition and the college would be providing their books.

**Shelly Lombard** suggested that the Montclair Fund for Educational Excellence might be able to provide funds for transportation since she feels some parents might not be in a position to do so.

*Mr. Lebida* responded that he agrees it would be worth looking into but would like to see any additional monies put toward allowing more students to take part in the program rather than putting the monies toward transportation.

Mr. Lebida thanked the Board for all their support during his years working for the Montclair Board of Education.

**Dr.** Alvarez asked how many students continued on at the college once they graduated and was told that many students do not continue after receiving their diploma but some do come back at a later time and that the counselors at the college work with the guidance counselors at the high school to follow up on the students.

9. "High School Organ and Tissue Classroom Guide"

Terry Trigg Scales stated that a requirement of the New Jersey Hero Act, which was signed into legislation in 2009 mandates that all residents make organ donation decisions before applying for a driver's license and requires organ donation education for high school students. Ms. Scales noted that schools in New Jersey will teach students between the ages of 5 and 20 the benefits of organ donations. Ms. Scales stated that Richard Codey decided that students should be educated so they in turn can educate their parents and community since being an organ donor is not just for the elderly but for the young as well. Ms. Scales noted that a letter will be sent home so the students can share the information with their family and that the curriculum guide which is required by the State of New Jersey covers three or four days of instruction with no cost to the district.

#### SUPERINTENDENT'S PRESENTATIONS:

## Dr. Alvarez stated:

- the Board will vote on a name for the new school and there will be discussion on how the recommendation came about at the time of approving the resolution
- the Board will vote on a new Principal for Watchung School
- the Board will advertise for Mr. Lebida's position as high school football coach and Assistant Principal. A community group will be formed but any potential candidates will not be included in the hiring process.

## 10. Naming of New School

## J. BOARD OF EDUCATION REPORTS

#### **Leslie Larson** stated:

- that she has attended many schools "Coffee with Dr. Alvarez" and school reviews and that the amount of commitment from parents and teachers is wonderful and she hopes that this will continue.
- that the Lucy Caulkins Writing Programs needs dollars to provide additional training for all teachers and possibly the Board can discuss how to obtain these funds.
- the Mt. Hebron school review wants to look at after school activities possibly the 21<sup>st</sup> Century Community Learning Center should be explored.
- the high school committee wants to improve school climate they discussed driver's education.
- the Board's website looks wonderful, is very informative and is a great place to obtain correct information, especially on the new school.

## Shelly Lombard, the PTA Council liaison, stated

- that the Budget Committee will be meeting and she feels this will be a tough budget year
- the Personnel Committee will be making an announcement regarding the Watchung Principal

*Carmen Taylor* stated that she will attend the fourth ward meeting on December 15, at which time James Earle, Montclair High School Principal, will discuss violence at the high school.

## **John Carlton** stated

- the Board will be having discussions on budget

- Dr. Alvarez and he have sent a letter to the Commissioner of Education stating their concerns with the proposed Charter School, which is to open in September since if the State approves the Charter School, it will have a great impact on the taxpayers of Montclair.

*Shelly Lombard* questioned whether it might be beneficial to ask that the issue of the Charter School be reconsidered now that James Earle is the leader at Montclair High and there are many positive things occurring there.

*John Carlton* responded that they could but he felt it would not do any good. Mr. Carlton announced that on January 19, the Finance Committee will be meeting to discuss school funding issues and the policies in Trenton. Mr. Carlton also announced that the New Jersey Monthly will have an article regarding the construction aspects of the new school.

#### 1. PTA

*Mary Beth Rosenthal*, Co-President of the PTA Council stated that the Council had a presentation by the Kirwan Institute to review the student placement policy and this was done at no charge to the district. Ms. Rosenthal noted that the presentation was very well received and was very impressive - the work was done by experts at the Kirwan Institute as well as attorneys and community members.

Ms. Rosenthal stated that the Council is gathering information from various schools to review various fundraising activities. Ms. Rosenthal commented that the Council is looking forward to meeting with Dr. Alvarez regarding the budget in January.

**Dennis Murray** commented that he was wonderful to hear about all the students who attained honors – it shows that there is success in the district and not failures.

c. Resolution re: Approval of the Montclair Board of Education's Partnership with the "Gateway to College National Network" Located at the Essex County College Newark Campus

WHEREAS, Gateway to College offers an alternative program of studies for students between the ages of 16 and 20 years old who have dropped out or on the verge of dropping out of high school, are behind in credits for age and grade level, have a GPA of 2.0 or below (or exhibit other risk factors), reside in an eligible district, have expressed the goal of earning a diploma, and read at an 8<sup>th</sup> grade level or higher, and

WHEREAS, Gateway to College is a sustainable partnership under which the district perpupil expenditure pays for tuition and books and the college uses its existing infrastructure to limit operational costs, and

e. Resolution re: Naming of the New School on Washington and Elm Streets

WHEREAS, the Montclair Board of Education will be opening a new school in September, 2010, and

WHEREAS, the school is on property that formerly housed the Washington Street YMCA, St. Vincent's Hospital and Nursing Home and the Mother Seton Residence Hall, and

WHEREAS, a community group was formed to make a recommendation to the Board of Education about commemorating the historical significance of the former YMCA, and

WHEREAS, the committee reviewed several suggestions and recommended the school be named in honor of Charles H. Bullock, a long-time Montclair resident and a former director of the YMCA,

NOW, THEREFORE, BE IT RESOLVED that the Montclair Board of Education hereby approves naming the new school The Charles H. Bullock School and authorizes the Superintendent to send the required paperwork to the County Superintendent of Schools.

I also think that many times when we build buildings, if we are building on a new site, you are sort of free to choose whatever name you want but I think there is something about the history of the site and the importance to the neighborhood that perhaps will cause people to think and I think in the past before this Board of Education, we have heard Sandra Lang speak of the importance of that Y to the neighborhood and to the community and certainly for many people whose children learned to swim there from that part of town - so that's my comments on the new school."

**Leslie Larson** expressed her concerns regarding sixth and eighth graders from Mt. Hebron attending movies. Ms. Larson noted that she was not objecting to the movie itself but hated to waste time that she felt time could be used more academically in light of the test scores.

Terry Trigg Scales responded that it is a tradition for Mt. Hebron.
