G. SUPERINTENDENT'S REPORT

Dr. Alvarez announced this evening's meeting should begin with the acknowledgment of the passing of Mr. Allan Elder, a beloved teacher at Hillside School who spent a great amount of his life influencing an entire generation of students.

Dr. Alvarez and the Board took a moment of silence in honor of Mr. Elder.

Dr. Alvarez commented on the article in the Montclair Times regarding the districts' Adequate Yearly Progress report (AYP). He stated a lot of time was spent talking about the districts' academic achievement but the article failed to capture the efforts of students and teachers. He added that he will write a letter in response to that article to set the record straight. He continued that the district does have some areas in need of improvement but students have been doing some tremendous work alongside the teachers who are making it happen on a daily basis, the work of the administration, and the efforts of the Department of Instruction. Most of the students are making progress from one year to another. Students have actually exceeded the trends of what students in similar districts' have achieved. He stated that this year all of the elementary schools made AYP. Two of the middle schools came off the list of schools that needed improvement. Renaissance and MHS had only failed one indicator out of 41. Overall, students are doing extremely well and for some of the schools where there were students that fell below the benchmark, many of the students represented different subgroup categories. Overall, the performance of the district has been strong. He encouraged all to visit the districts' web-site for an update on the progress of the students and to shed some light on what has been gong on in the district.

Dr. Alvarez announced that the district is sponsoring a forum on Thursday, January 28, 2010 in the George Inness Annex at 7:00 p.m. entitled "Understanding State Funding and Implications for the Montclair Public Schools". He indicated that during this budget season the Board wants people to understand how schools are funded in New Jersey and the implications at the local level. The discussion will be a paneled presentation by a number of experts reviewing funding at the state level and ultimately how it impacts the Montclair Public School District.

MHS Student Coalition

David Ellman and Jamie Fanous stated that there have been organizations being created to help support funding for Haiti. There was a fundraiser at the Basketball game this weekend in which all of the proceeds went to Haiti. Mid-term exams are this week and all students are stressed and looking forward to second semester which begins on Monday, February 1. In sporting news, Montclair Kimberly Academy and Montclair High School are playing for the Montclair Cup in hockey on Thursday, January 28 at 4:30 pm. The

swim team is participating in the state tournament on Saturday, January 30. The MHS student coalition had been attending the monthly school review meetings and encouraged all to attend them as well.

I. MINUTES

Mrs. Lombard moved to approve the following minutes:

Public Board Meeting held on Monday, January 11, 2010

Seconded by Ms. Grill and approved by a vote of 6-0 with 0 abstentions.

J. BOARD OF EDUCATION REPORTS

Mr. Carlton stated that the most important topic the district is working on is refocusing the magnets system themes. This involves reviewing programs in the district that will strengthen the magnet themes, programs

that have become extraneous, and programs that are weakening the magnet themes. There are sub-committees reviewing various non-instructional areas of the budget. The Board is looking for several million dollars in savings in this years' budget which include areas not required by the state, restructuring programs with technology or other ways where the district can provide a higher quality of service and/or a lesser dollar amount.

Ms. Larson stated that they are reviewing the quality of education to see if there are ways to become more efficient in certain areas.

Mrs. Lombard stated that this year the attention is on focusing dollars in places where they do the most good and deemphasizing spots that do not serve our students.

Ms. Grill stated that she thinks it's more than looking closely and focusing on fulfilling the primary mission which is to ensure a good education for all children. She added that the Board will make sure that dollars are spent in targeting children who are at risk which is very important. She stated that in the past the district has been able to maintain the budget by working around the edges. However, she doesn't think that would be possible this year and that people should get that message early. She stated that the Board has a fundamental commitment to making sure that all kids get an education and that cuts will not begin at the bottom. She concluded that difficult decisions and cuts will need to be made in the district.

The Board had the second reading of the Freedom of Choice (School Selection and Assignment) Policy P-5117 and Registration/Freedom of Choice and School Assignment Regulation R-5117

K. COMMENTS

1. PTA

Marybeth Rosenthal and Sally Coughlin congratulated the Board on the development of the New School Assignment policy and that the PTA Council appreciates the work that was put into the forward initiative thinking. She stated that the PTA Council is planning to hold a parent-to-parent meeting in February to talk about the process of PTA's to enhance their children's education experience.

2. MEA

Dennis Murray stated that he appreciates the moment of silence for Alan Elder.

He stated that he was very angry at the Montclair Times headline regarding the failure of the Montclair Public School District. He continued that it is a misrepresentation of the district since most people do not read past the headlines and that this brings negativity to the district's reputation. Mr. Murray informed the Board that Governor Christie's transition report spells out big trouble for public schools. He mentioned that the date of the MEA retirement dinner is changed to May 18 since there are so many things going on in the district on May 19. He also informed the Board that the MEA would like to assist the Board in developing a more palatable budget.

2. Board Members

Mrs. Taylor stated that she attended the 21st Annual Dr. Martin Luther King Jr. Scholarship breakfast and said that the district should be very proud of the young men who presented that evening.

Ms. Grill asked a question about the teams that presented at the "We the People" event.

Ms. Larson attended the Academic Sub-Committee meeting where they reviewed the benchmarks for writing at each grade level, discussed the professional development day, and tutoring preparation for students taking the NJASK test. She added that she went with Dr. Alvarez to "Coffee at Northeast School" where they discussed writing curriculums, school funding, non-residence students, and class size. She concluded that she attended the monthly guidance meeting where they discussed information about the change in the Montclair High Schools' policy regarding students being present in school the whole day of their mid-term exams.

Mrs. Lombard stated that she attended a school review meeting last week where Mr. Earle's policy for mid-term exams was an excellent idea. She said that Mr. Earle is making sure that all teachers report grades on Star Portal so that parent's can review. All of these changes are very good things that are happening in the high school. She also commented on school funding stating that it is going to be a difficult budget season She encouraged all to go to the State Funding meeting on Thursday evening.

Mr. Kautz attended the quarterly meeting for the MFEE where they accrued \$100,000 in proceeds from Montclair Rocks! MFEE is in the process of meeting with the principals in the schools in order to allocate those funds. He congratulated the National Merit Scholarship award recipients. He concluded by giving his condolences to the Elder family in their time of loss and agreed that Mr. Elder will be sorely missed.

Ms. Grill pointed out that when missing certain elements in AYP does not mean that we have a failing school. There are kids that didn't pass. We have schools where children need more from the district. They are good successful schools and that language needs to be changed.

Mr. Carlton talked about the upcoming school funding forum. He stated that he will be speaking along with the other experts on Thursday evening. He said he spent about nine months trying to answer the question of why taxes are high in Montclair. He indicated that unfortunately, it is very hard to answer that question and one of the reasons is that data exists in three different areas such as tax assessment data, land-use data, and department of education data. It does not correlate exactly and it is very difficult to compare things. While Montclair probably spends about the same amount per student as other districts the Montclair funding source is much different. The average school portion for housing tax in Montclair is about \$10,000.00. West Orange spends more per student than Montclair and their housing tax is a little over \$7,500.00. The difference is made up in non-single family houses. Wayne school district spends slightly less than Montclair and their single family burden is only \$6, 200.00 per average household. The specific question is why are single family houses in Montclair paying such high taxes relative to the state. He stated that this will be discussed along with several other questions such as what is the make up of the residential community in terms of housing stock and what is the make up of the non-residential community as a ratable base and overall population. The enrollment report showed a bell curve where there were many more students for the same amount of people. He said that when comparing Montclair to West Orange, Montclair has more students but less residents, so Montclair have fewer people paying for more students.

Mr. Carlton indicated that in regards to state aid, Montclair does not receive a large portion of their budget -approximately 9% from the state. The average in the state is around 39%. He also noted that Montclair has certainly taken on as a mission that is perhaps a much broader educational mission than some of the other communities. He stated that when you look at Livingston and Ridgewood – districts that may not have significant, if any, proportions of economically disadvantaged students, Montclair has 15%-18% consistently. The extra money the district receives from the state does not begin to address the things the Board feels need to be addressed for that population. The experts will address matters concerning politics, procedures, and what possible actions of the budget. He concluded by stating that when you look at the enrollment report at the per student cost of Montclair it becomes a pretty good

bargain as compared to Mountain Lakes, Princeton High School who are spending thousands more per student. Montclair does have some economies of scale of deficiency because of size but a lot of times Montclair is compared to districts that spend a lot more and have a lot more resources but do not take on the mission of educational service as Montclair. He stated that he hope that some of those things will be educational for a lot of people since it is not a cost issue but a revenue issue in Montclair.
