Laura Hertzog moved to approve the following resolution:

Resolution Re: Search Updates

WHEREAS Montclair has been without a permanent Superintendent of Schools since May 1, 2015; and,

WHEREAS Interim Superintendent Bolandi must leave his position no later than April 30, 2017, just over 10 months from now; and,

WHEREAS members of the Montclair Board of Education and the public have expressed deep concern that there has been no initiation of a search for a replacement for Interim Superintendent Bolandi; and,

WHEREAS members of the Montclair Board of Education and the public have expressed concern about a lack of transparency in the last search for a permanent Superintendent; and,

WHEREAS it is a key responsibility of the entire Board to proceed collaboratively and expeditiously with the search for the next Superintendent, and that collaboration cannot take place unless all Board members are equally informed; and,

WHEREAS members of the Montclair Board of Education and the public have expressed concern about a significant number of openings in senior leadership positions in the District, and a need for greater understanding of the progress on filling these positions;

NOW THEREFORE BE IT RESOLVED that the Board President will provide the full Board with a draft job description for the Superintendent position no later than June 15, 2016, for review and subsequent discussion and approval by the full Board.

BE IT FURTHER RESOLVED that effective June 17, 2016, the Board President will provide the full board with written weekly updates, on or before Friday of each week, providing status reports

on the searches for Superintendent, Director of Pupil Services, Assistant Superintendent, Director of Guidance, Director of Personnel and any other positions that report or co-report to the Superintendent. The Superintendent will provide information to the president of all searches other than the Superintendent search.

BE IT FURTHER RESOLVED that a new Agenda item "Search Updates" will be added to the Executive and Public Agendas of each Board of Education meeting until further notice. As the first item in every Executive Session, the Board President will provide the full board with a detailed verbal update on each of the above searches. In Public Session, as an Agenda item immediately after the Superintendent's Report, the Board President will provide the public with verbal updates on the above searches at each Board meeting until further notice, providing the public with all information she is able to provide without violating relevant rules with respect to personnel and confidentiality.

BE IT FURTHER RESOLVED that, effective immediately, any and all emails sent to all Board Members referencing or discussing the above searches, whether sent to Board email addresses or private email addresses, and any responses to those emails, will be forwarded to all Board members within 24 hours of being received or sent, so that the entire Board has all information regarding said searches, and may appropriately exercise its oversight responsibilities with regard to these searches, as the Board is required and permitted to do by law.

BE IT FURTHER RESOLVED that, in addition to providing the emails referenced above, effective immediately all Board members will provide the full board on a weekly basis, no later than Friday of each week, with written summaries of any and all texts, conversations or other non-email communications in which they have participated regarding the above searches. These summaries may be included as part of the President's written weekly updates referenced above, or separately, whichever is more convenient for the Board leadership.

BE IT FURTHER RESOLVED that no search consultant, firm or other agent may be hired for the Superintendent search on behalf of the Board without a majority vote of the full Board, following a full discussion by the Board of the merits of hiring such an agent.

BE IT FURTHER RESOLVED that at the Board's final spring meeting of June 20, 2016, the Board President will provide the full board and the public with a detailed, comprehensive proposal on the actions she intends to take or have taken between June 20 and the Board's first meeting in August, 2016, to advance the above searches. Such report will include but not be limited to specific plans for ensuring public engagement in the process of hiring the next Superintendent.

WHEREAS the Board recently unanimously approved a resolution introduced by the Board Vice President re Management Reporting; and,

WHEREAS not only Management Reporting but reporting from leadership to the entirety of a governance organization is vital to the ability of the organization effectively to execute its mandate; and,

WHEREAS members of the Montclair Board of Education have expressed the need for greater transparency and organization of information flow from its officers to the full board; and,

WHEREAS in the Board's Governance meeting on April 30, 2016 and in other meetings the Board has discussed the need to build Board competence and to increase public engagement with and confidence in the Board; and,

WHEREAS an increase in the availability of information to the full Board and to the public will increase public confidence in the Board's performance of its governance function, and better educate less experienced Board members as to their roles and responsibilities,

NOW THERFORE BE IT RESOLVED that effective immediately and continuing through May 14, 2017, the Board President (and the Board Vice President on occasions where she is acting with or in place of the President), will provide regular written updates to the full Board summarizing all written or oral communications with the Board attorney, (with regard to the Board attorney, the President will use discretion to determine the level of detail provided), the Superintendent, the MFEE, any group or organization engaged in raising money on behalf of or for the benefit of the Montclair Public Schools, elected officials and/or any individual on the district payroll, regarding any legal, personnel or financial matters.

BE IT FURTHER RESOLVED that this reporting is to be received by the full Board at regular intervals, no less frequently than biweekly, and

BE IT FURTHER RESOLVED that during this time period an Agenda item be added to the first public meeting each month titled "Committee, Liaison and Conference Reporting". At each such meeting, chairs of each Board committee (or their designees) will provide the full Board and the public with a comprehensive report on the activities of their committees in the preceding month. In addition, any member of the Board who acts as liaison or representative to an outside organization (e.g. Urban School

Boards, MFEE, etc.) will provide the full Board and the public with an oral report on his or her activities in that role in the preceding month. Finally, any member of the Board who has attended any conference or meeting at District expense in the preceding month will provide the full Board and the public with an oral report on the knowledge derived from that conference or meeting. To the extent any such reports would involve information that may not be discussed in public session, said reports will be delivered solely to the Board, as a scheduled Agenda item in Executive session.

1. Resolution Re: Approval of Agreement of Separation of Technology Services With Township

Anne Mernin moved to approve the following resolution:

- WHEREAS, on June 15, 2015 the Montclair Board of Education approved raising funds for district-wide HVAC work, site improvements, environmental work, furniture and equipment, technology and building modifications; and
- WHEREAS, the Montclair Board of School Estimate on July 9, 2015, approved a subset of those projects for 2015-2016, with estimated project costs of \$2,536,000, plus Section 20 costs of \$101,440, and authorized funding through the issuance of school bonds; and
- WHEREAS, the funding for technology work incorporated plans to execute a separation of core technology services between the school district and the Township, as expressly discussed with the Montclair Board of Education and the Montclair Board of School Estimate; and
- WHEREAS, the execution of the project for separation of services will impact the technology operations of both the school district and Township; and
- WHEREAS, the execution of the project for separation of services requires an equitable distribution of certain shared equipment, software and licenses; and
- WHEREAS, relevant school district and Township officials have met on multiple occasions to review and discuss project parameters and timelines, the impact on operations, and the distribution of shared equipment, software and licenses and have agreed in principle to the attached draft agreement; and
- WHEREAS, the Township officials have agreed to present this draft agreement to the Township Council for approval;
- IT IS THEEFORE RESOVED, that the Montclair Board of Education approved this draft agreement and authorizes the Business Administrator/Board Secretary to execute the agreement with the Township upon confirmation that it has also been approved by the Township Council.
