The contract was awarded to GK Fotinos, LLC, 281 State Route 79 North, Morganville, NJ in the total amount of \$230,391.38 (\$224,391.38 base bid plus Alternate #1 for \$3,000.00 and Alternate #2 for \$3,000.00), and

WHEREAS, the project is now substantially complete and the allowance for contingency of \$25,000.00 built into the total cost of the project, less approved deductions from the allowance of \$15,391.86, results in the unused amount of \$9,608.14,
