3. Resolution: Re-Authorization of School Bonds

Joe Kavesh moved to approve the following resolution:

WHEREAS, The Board of Education of Township of Montclair in the County of Essex, New Jersey (the "Board") has determined that unspent bond proceeds for completed school capital projects or not needed for pending school capital projects nearing completion either should be applied to the payment of the principal of bonds issued for such purposes or appropriated for a new school capital project as permitted and required by law pursuant to N.J.S.A. 18A: 7G-5(o), N.J.S.A. 18A:24-48 and 49 and N.J.A.C. 6A:26-4.6; and

WHEREAS, N.J.S.A. 18A:24-48 requires that the Board of Education determine and prepare and deliver a statement to each member of the Board of School Estimate that proceeds of bonds issued for a school purpose are not necessary for the purpose for which the bonds were issued and that such proceeds in an estimated amount are required for another itemized school capital purpose or purposes; and

WHEREAS N.J.S.A. 18A:24-49 provides that upon receipt of such statement, the Board of School Estimate shall fix and determined the amount of such proceeds necessary for the new capital purpose or purposes and certify the same to the Board of Education and the municipality comprising the district, whereupon such proceeds, to the extent so fixed and determined, may be used by the Board of Education for the new capital purpose or purposes; and

WHEREAS the term "School Bonds" as defined in N.J.S.A. 18A:24-1(g) and the word "bonds" as used herein includes both bonds and notes for school purposes; now, therefore,

BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE TOWNSHIP OF MONTCLAIR IN THE COUNTY OF ESSEX, NEW JERSEY as follows

1. Proceeds of Notes issued for school purposes by the Township of Montclair in the amount of \$15,325 pursuant to bond ordinance No. 08-14 shall be used to pay down a portion of the principal payment due on the Township's \$81,000 Note outstanding

under the bond ordinance at maturity on November 2, 2018. This school capital project is complete.

2. Proceeds of School Bonds issued for school purposes by the Township of Montclair in the amount of \$14,825 pursuant to bond ordinance No. 10-28 shall be used to pay down a portion of the principal payment due on the Township's \$22,000,000 School Bonds outstanding under the bond ordinance, due on March 1, 2018. This school capital project is complete.

3. It is hereby determined that unspent proceeds of School Bonds in the amount of \$26,825 issued under ordinance number 06-30, \$88,703 issued under ordinance number 07-26, \$2,646 issued under ordinance number 11-41, \$154,512 issued under ordinance number 12-32 and \$53,434 issued under ordinance number 13-17 of the Township in the aggregate amount of \$326,120, for projects nearing completion, are no longer necessary for the purposes for which the bonds were issued.

4. It is hereby determined that the \$326,120 available pursuant to section 3 hereof is necessary to fund the installation of carbon monoxide detectors and security upgrades in buildings district wide. A Certificate shall be prepared and delivered to each member of the Board of School Estimate informing them that \$326,120 is necessary for such purpose along with a request that the Board of School Estimate fix and determine that this amount is necessary for this school capital purpose and certify the same to this Board of Education and the Township of Montclair, whereupon such proceeds, to the amount so fixed and determined by the Board of School Estimate, shall be deemed reappropriated for this new purpose

4. Resolution: The Board of Education of the Township of Montclair Determining to Raise Money for School Capital Projects Through the Issuance of School Bonds

Joe Kavesh moved to approve the following resolution:

WHEREAS, The Board of Education of the Township of Montclair in the County of Essex, New Jersey (sometimes herein referred to as the "Montclair Board of Education") has determined pursuant to N.J.S.A. 18A:22-18 that it is necessary to sell school bonds to raise money for the capital purposes and in the estimated amounts described in the Statement attached hereto; and

WHEREAS, the Montclair Board of Education intends to seek school facilities aid in the form of debt service aid and now requires funding for the projects to commence preliminary planning to develop the plans and specifications and the applications to the Department of Education for its approvals of the projects; and

WHEREAS, the Montclair Board of Education has determined to deliver the attached Statement to each member of the Board of School Estimate to request them to fix and determine the amount necessary for the projects as set forth therein and to certify such amount to this Board of Education and to the Township of Montclair pursuant to N.J.S.A. 18A:22-19;

WHERAS, this Board of Education will prepare and deliver to each member of the Board of School Estimate an amended Statement once it receives the preliminary eligible cost and final eligible cost letters for the projects from the Department of Education; now therefore

BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE TOWNSHIP OF MONTCLAIR IN THE COUNTY OF ESSEX, NEW JERSEY, as follows:

Section 1. This Board of Education hereby determines that it is necessary to sell school bonds to raise money in the amount of \$3,400,000 for the capital projects described in the Statement attached hereto;

Section 2. The Business Administrator is hereby directed to send a certified copy of the this resolution and the Statement attached hereto to each member of the Board of School Estimate

and to request them to fix and determine the amount necessary for the projects as set forth therein and to certify such amount to this Board of Education and to the Township of Montclair pursuant to N.J.S.A. 18A:22-19;

Section 3. The Business Administrator is further authorized, together with other appropriate Board representatives under his direction, to make applications for project approval and a determination of eligible project costs and, upon receipt of the preliminary and final eligible cost letters from the Department of Education, to revise the Statement in accordance therewith, and to send the revised Statement to each member of the Board of School Estimate.

Section 4. This resolution shall supersede the resolution of this Board of Education adopted March 14, 2016.

Section 5. This resolution shall take effect immediately.
